Chairman Gary Rodgers called the meeting to order at 5:05 pm.

Mrs. Bisson made a motion relative to a personnel issue, seconded by Mrs. Langlais. The motion was adopted unanimously.

Mrs. Langlais moved, seconded by Mr. Christiansen, to seal the text of the previous motion until February 2011. The motion was adopted unanimously.

Mrs. Bisson moved, seconded by Mr. Lavoie, to extend Ann Merrill's contract as CTE Director until December 30, 2010. The motion was adopted unanimously.

The Board directed the Superintendent to post the position of CTE Director, effective January 1, 2011, on an internal basis.

Mr. Lavoie moved, seconded by Mrs. Langlais, to include health insurance in the Superintendent's contract, with a continued salary level of \$116,500, effective July 1, 2010. The motion was adopted unanimously.
